Balancing Advocacy and the Need for Personal Connections in the Criminal Justice System by

Prosecuting attorneys play a crucial role in advocating for justice on behalf of victims within the criminal justice system. Oftentimes we hear, "I am not good at talking to victims..." However, striking a balance between the vigorous pursuit of justice and meeting victims' profound need for personal connections and empathy can be challenging. In this article, we examine the struggles faced by attorneys in navigating this delicate balance and the importance of understanding and addressing the emotional needs of victims throughout the criminal justice process.

Advocating for justice requires prosecuting attorneys to approach cases with objectivity, relying on facts, evidence, and legal strategies. The primary goal is to ensure that the legal process is fair and impartial, seeking justice for both the victim and the defendant. This commitment to justice can sometimes create a perception of detachment, as attorneys focus on legal strategies rather than establishing deep personal connections. On the other hand, victims of crime often experience trauma, fear, and a range of complex emotions throughout the criminal justice process. They may seek emotional support, understanding, and empathy from victim advocates, but they yearn for an attorney who not only fights for justice but also acknowledges their pain and provides a compassionate presence during a difficult time.

Striking a balance between vigorous advocacy and fulfilling victims' need for personal connections can be challenging for attorneys. The attorney's role as an advocate requires them to maintain a level of professional detachment to ensure an objective and effective legal representation. However, this can create a perceived emotional distance that may leave victims feeling unheard or disconnected. Sometimes this may cause attorneys to feel they need to just focus on the law, but the more seasoned attorneys will tell you there are ways to strike a sweet balance.

Prosecuting attorneys often experience a complex mix of emotions and conflicts when working on cases involving victims. On one hand, they are driven by their duty to seek justice for the victim and hold the offender accountable for their actions. They feel a sense of responsibility to ensure that the victim's voice is heard and that their rights are protected throughout the legal process. However, they also face the challenge of maintaining a professional distance to remain objective and unbiased. They must separate their personal emotions from their role as legal advocates. This can be particularly difficult when dealing with cases that involve heinous crimes or deeply traumatic experiences for the victim. The emotional toll of working on such cases can be immense. Attorneys may experience a range of emotions, including anger, sadness, frustration, and empathy. They witness firsthand the pain and suffering endured by the victims and their

families, which can have a profound impact on their own well-being.



LAW CORNER

Downward Departures under 17-10-6.1(e)

Under O.C.G.A. §17-10-6.1(e) and relevant code sections for these specific offenses, Armed Robbery, Kidnapping, Rape, Aggravated Child Molestation, Aggravated Sodomy, and Aggravated Sodomy all have mandatory minimum sentences ranging from 10 years to 25 years that a Defendant is required to serve. That subsection entitles the prosecution, and ONLY the prosecution, to deviate below the mandatory minimum sentence in a negotiated plea agreement when an agreement is reached between both parties. For example, the Prosecutor agrees to recommend a 20 serve 6 sentence on an Armed Robbery (mandatory minimum sentence of 10 years) or Life serve 15 years on a Rape charge (mandatory minimum sentence of 25 years followed by life on probation) in a exchange for a plea which the Defendant will agree to. The obvious benefit is a pre-trial resolution while the Defendant pleads to the charge on the indictment without having to amend the charge to a lesser included offense. The Judge has the options of accepting or rejecting the sentence, but DOES NOT have the authority to deviate even further below the agreed upon deviation agreed to by the prosecution and defense. This is because subsection (e) of the statute expressly states in clear and unambiguous language that judge may depart from mandatory minumums only at the agreement of the state and defense. Without such agreement, the Court only has the authority to sentence in accordance with offense code section and a recidivist statute under O.C.G.A. §17-10-7, if one has been filed. The Court of Appeals recently addressed this matter, dictating that the trial court has no authority to deviate below mandatory minimums under § 17-10-6.1(e) unless agreed upon by the State. See State v. Dixon, 370 Ga. App. 211 (2023). In Dixon, the Walton County District Attorney's Office agreed to a 20 serve 6 sentence on an Armed Robbery charge that the Defendant agreed to accept. At the sentencing hearing, the trial court found mitigating evidence to deviate below the agreed upon 6 years. The State appealed and the Court of Appeals vacated the sentence due to it being void of authority by the trial court. This generally does not happen, but is it does, the proper thing to do is to recite the statute and the Dixon case and if the trial court continues to proceed with its own sentence, object on the record and notify your direct supervisor and the appellate unit so that affirmative steps can be taken to address the issue.


BREAK THE SILENCE




Khristina Sanders

Dear Ms. Hollander,

I am writing to you on behalf of the Animal Legal Defense Fund (ALDF), a national, nonprofit organization of attorneys who specialize in the protection of animals and who work to ensure the enforcement of existing animal protection laws. This month, the grant-funded Emmett Till Cold Case Investigations and Prosecution Program facilitated the training titled "Enhancing Investigations Through Genetic Genealogy," which took place on March 12 and 13. The training delved into the application of Forensic Genetic Genealogy (FGG) and its role in aiding investigations. Techniques covered included tips on utilizing genealogy to establish the identities of cold case suspects and assist in the identification of human remains. Instruction was provided by experienced investigators who have acquired expert knowledge in the application of forensic genealogy through real-life cases. Topics included forensic genealogy techniques, investigative strategies for developing leads and information, as well as collaboration with private labs and other related resources.

The training was attended by Deputy District Attorney Vincent Faucette, Senior Assistant District Attorney Brian Trepanier, Assistant District Attorney Robert Wilson, Cold Case Senior Investigator Darnel Kennedy, and Emmett Till Grant Coordinator SaQuez King.
