LAW CORNER

How to Deal with Unresponsive Witnesses

As prosecutors who have the burden of proof at trial, much of our time is spent questioning witnesses on direct examination. This mode of examination requires us to ask open ended questions of our witnesses that do not lead to a desired answer. A “leading” question does just that. See *Denson v. Miller*, 33 Ga. 275, 278 (1862) (a question is leading when it suggests to the witness the desired answer). Under O.C.G.A. §24-6-611(c), leading questions are generally only permitted during cross examination of witnesses. Therefore, a prosecutor's opportunity to ask leading questions will come when cross-examining defense witnesses after the state has rested their case in chief. However, there are exceptions to this rule that permit prosecutors to ask leading questions during direct examination when it is “necessary to develop the witness's testimony” and/or when dealing with a “hostile witness, an adverse party, or a witness identified with an adverse party.” O.C.G.A. §24-6-611(c). The Supreme Court of Georgia recently took up this issue and reaffirmed the ability of prosecutors to ask leading questions when dealing with an unresponsive witness. See *Brown v. State*, 2022 Ga. LEXIS 183 (2022). In *Brown*, the Alapaha Judicial Circuit District Attorney's Office were prosecuting the Defendant for the shooting death of the Victim in a parking lot. Witness Tyeesha Gray was present during the shooting and told the police she observed the Defendant shoot the Victim. At trial, she testified on direct examination that she simply saw the Victim get shot but didn't know who shot him. After several questions where she was being evasive and responding “I don't know”, the Prosecutor made a motion to treat Ms. Gray as a hostile witness. The Prosecutor indicated to the Trial Court that Ms. Gray was being “clearly non responsive. She's only answering part of the question. She's answering that she knows and then she says she doesn't know, so I'd ask at this time to be able to lead her.” The Trial Court granted the motion and permitted leading question. On Appeal the Defendant's attorneys argued that Ms. Gray's “unresponsiveness” to questions on direct examination did not make her a “hostile” witness under Rule 611(c). The Supreme Court disagreed and indicated that an unresponsive witness can be treated as a hostile witness, citing federal authority to support that assertion. See *United States v. Postell*, 891 F2d 287 (4th Cir. 1989) (leading questions were permitted to develop witness's testimony where the witness was disinclined to “answer fully the prosecution's questions”); *United States v. Brown*, 603 F2d 1022, 1025-1026 (3) (1st Cir. 1979) (leading questions permitted where, among other things, the witness's testimony was “replete with lapses of memory”).

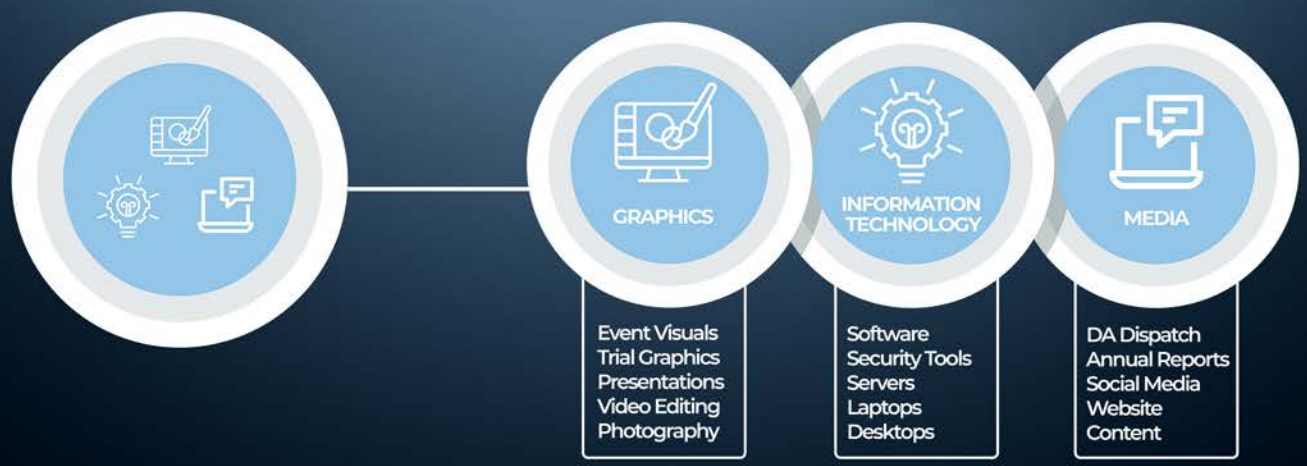

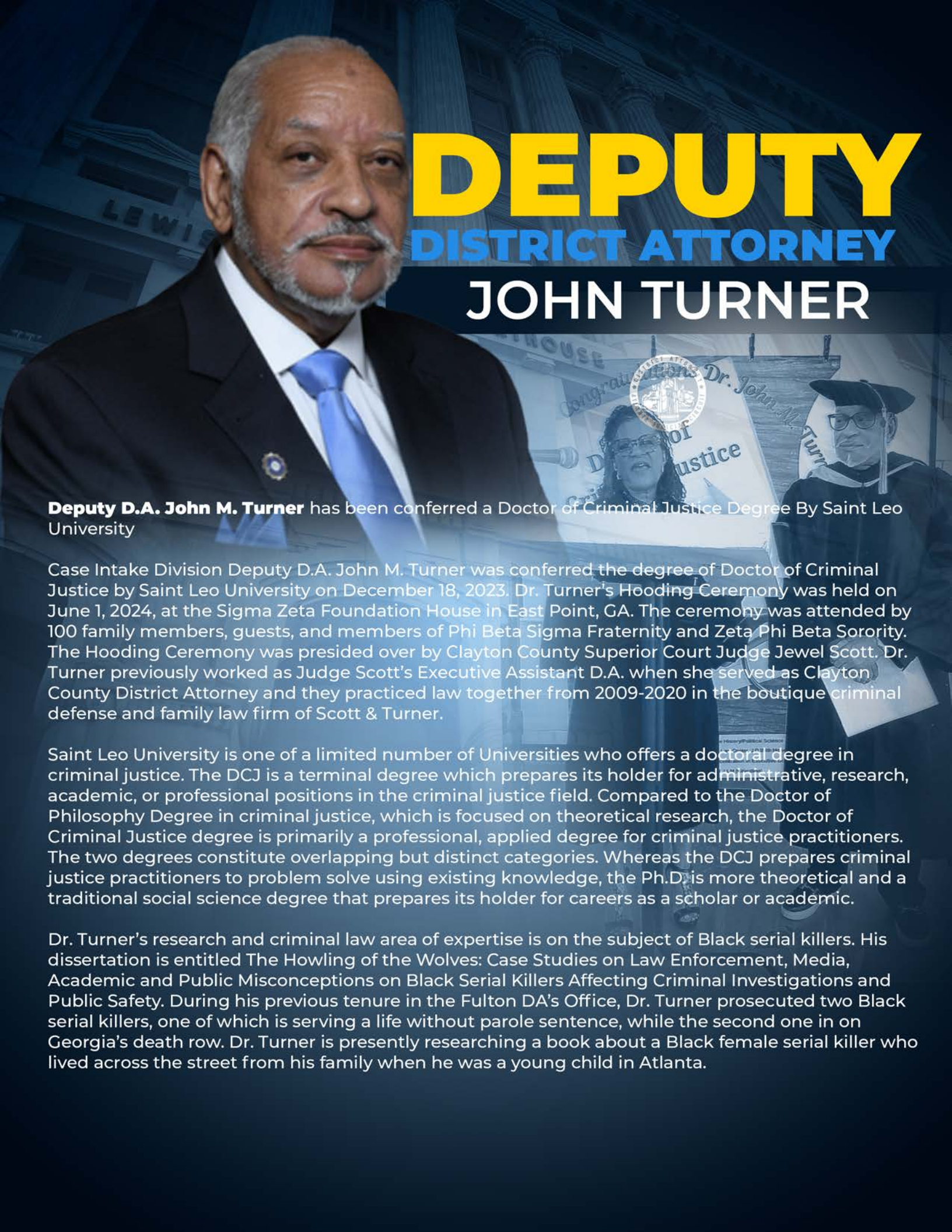

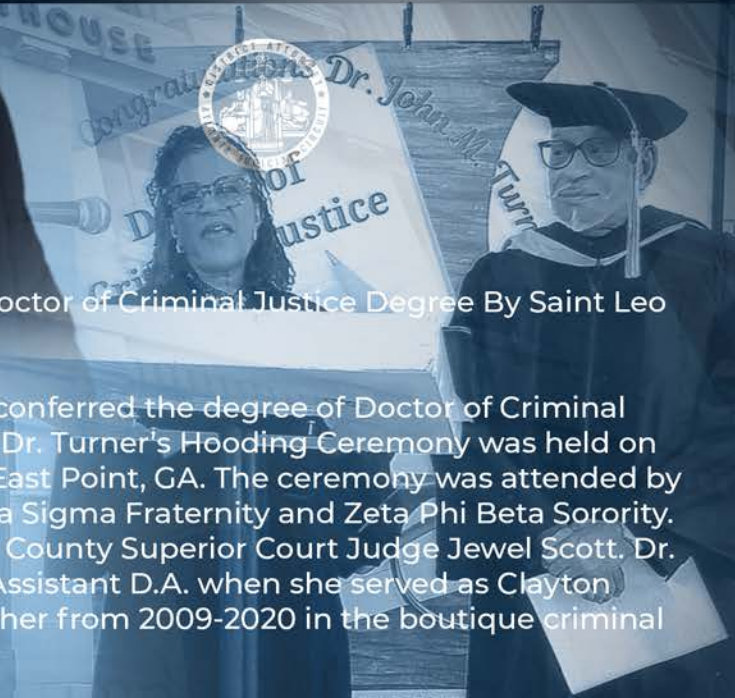
DEPUTY DISTRICT ATTORNEY JOHN TURNER

Deputy D.A. John M. Turner has been conferred a Doctor of Criminal Justice Degree By Saint Leo University

Case Intake Division Deputy D.A. John M. Turner was conferred the degree of Doctor of Criminal Justice by Saint Leo University on December 18, 2023. Dr. Turner's Hooding Ceremony was held on June 1, 2024, at the Sigma Zeta Foundation House in East Point, GA. The ceremony was attended by 100 family members, guests, and members of Phi Beta Sigma Fraternity and Zeta Phi Beta Sorority. The Hooding Ceremony was presided over by Clayton County Superior Court Judge Jewel Scott. Dr. Turner previously worked as Judge Scott's Executive Assistant D.A. when she served as Clayton County District Attorney and they practiced law together from 2009-2020 in the boutique criminal defense and family law firm of Scott & Turner.

Saint Leo University is one of a limited number of Universities who offers a doctoral degree in criminal justice. The DCJ is a terminal degree which prepares its holder for administrative, research, academic, or professional positions in the criminal justice field. Compared to the Doctor of Philosophy Degree in criminal justice, which is focused on theoretical research, the Doctor of Criminal Justice degree is primarily a professional, applied degree for criminal justice practitioners. The two degrees constitute overlapping but distinct categories. Whereas the DCJ prepares criminal justice practitioners to problem solve using existing knowledge, the Ph.D. is more theoretical and a traditional social science degree that prepares its holder for careers as a scholar or academic.

Dr. Turner's research and criminal law area of expertise is on the subject of Black serial killers. His dissertation is entitled The Howling of the Wolves: Case Studies on Law Enforcement, Media, Academic and Public Misconceptions on Black Serial Killers Affecting Criminal Investigations and Public Safety. During his previous tenure in the Fulton DA's Office, Dr. Turner prosecuted two Black serial killers, one of which is serving a life without parole sentence, while the second one in on Georgia's death row. Dr. Turner is presently researching a book about a Black female serial killer who lived across the street from his family when he was a young child in Atlanta.
