- 1 A RESOLUTION OF THE FULTON COUNTY BOARD OF COMMISSIONERS
- 2 ADDRESSING THE IMPORTANCE OF HEALTHY INDOOR AIR QUALITY BY
- 3 ENCOURAGING ADEQUATE FILTRATION, HUMIDITY CONTROL, AND
- 4 VENTILATION IN RESIDENCES WITHIN FULTON COUNTY, GEORGIA; URGING
- 5 THE FULTON COUNTY BOARD OF HEALTH AND OTHER FULTON COUNTY
- 6 AGENCIES WITH THE ABILITY TO EDUCATE AND INFLUENCE LANDLORDS,
- 7 OCCUPANTS, HOMEOWNERS, AND TENANTS TO PROVIDE INFORMATION TO
- 8 THE PUBLIC ABOUT IMPROVING INDOOR AIR QUALITY WITH THE GOAL OF
- 9 REDUCING SUFFERING AND THE FINANCIAL BURDEN OF HEALTH CARE
- 10 TREATMENT ASSOCIATED WITH POOR INDOOR AIR QUALITY; AND FOR
- 11 OTHER PURPOSES.
- 12 WHEREAS, Fulton County's Strategic Plan for 2021 2025 calls upon the Board of
- 13 Commissioners to "prevent health disparities by educating residents and connecting them to
- 14 available resources"; and
- 15 WHEREAS, this wellness initiative grows from the "All People Are Healthy" vision statement in
- Fulton County's previous Strategic Plan, with the objective of reducing the rates of disease and
- unhealthy medical conditions, thereby preventing the need for health care services, which is a more
- 18 cost-effective solution than treating the symptoms, and is consistent with Fulton County's strategic
- 19 objective of delivering efficient and effective county services; and
- 20 WHEREAS, the Fulton County Sustainability & Resilience Plan published in 2019 calls for
- 21 "supporting an Indoor Air Quality Education Campaign" and "improving occupant health and
- 22 productivity through better Indoor Environmental Quality"; and
- 23 WHEREAS, studies indicate that the air indoors, where we spend most of our time, often contains
- 24 gaseous chemicals, particulates, and microbial growth that have been linked to the onset or
- 25 exacerbation of many major chronic diseases including Cardio-vascular Diseases, Diabetes,
- 26 Asthma, and COPD, as well as certain Cancers and Neurological Disorders (see e.g.,
- 27 <a href="https://www.epa.gov/report-environment/indoor-air-quality#health">https://www.epa.gov/report-environment/indoor-air-quality#health</a>); and
- 28 WHEREAS, particulate can be removed with adequate filtration; gaseous chemicals can be
- 29 diluted with adequate conditioned ventilation, and microbial growth can be mitigated with
- 30 adequate humidity control, as described at https://www.epa.gov/indoor-air-quality-iag/air-
- 31 cleaners-and-air-filters-home, reducing the burden of health-related suffering and the financial
- 32 burden resulting from indoor air contaminants; and
- 33 WHEREAS, The American Society of Heating, Refrigerating and Air-Conditioning Engineers
- 34 ("ASHRAE") recommends the use of Minimum Efficiency Reporting Value ("MERV")-13 filters
- 35 for COVID-19 safety, and which is at least 85% efficient at capturing particles in 1 μm to 3 μm
- size range (see https://www.ashrae.org/technical-resources/filtration-and-disinfection-faq); and,
- 37 WHEREAS, The White House has announced a National Initiative "to accelerate the adoption of
- modern building codes to improve resiliency", found at https://www.whitehouse.gov/briefing-
- 39 room/statements-releases/2022/06/01/fact-sheet-biden-harris-administration-launches-initiative-

- 40 to-modernize-building-codes-improve-climate-resilience-and-reduce-energy-costs/, which
- supports the BOC finding that including appropriate filtration, humidity control, and conditioned
- ventilation is fundamental for "All People to be Healthy"; and
- WHEREAS, minorities, children living below the poverty line, and other marginalized residents
- are disproportionately exposed to unhealthy indoor air quality, according to the U.S.
- 45 Environmental Protection Agency's studies of indoor air quality and environmental justice; and
- WHEREAS, the Fulton County Board of Health is authorized to "[t]ake such steps as may be
- 47 necessary to prevent and suppress disease and conditions deleterious to health...", pursuant to
- 48 O.C.G.A. §31-3-4(a)(3).
- 49 NOW THEREFORE, BE IT RESOLVED, that the Fulton County Board of Commissioners
- 50 hereby declares the importance of filtration, humidity control, and conditioned ventilation to
- reduce the needless suffering and the preventable financial burdens associated with poor indoor
- 52 air quality within residences of Fulton County.
- 53 BE IT FURTHER RESOLVED, that the Fulton County Board of Commissioners hereby
- 54 encourages the Fulton County Board of Health to provide public service announcements and
- educational materials for the public that reflects the importance of filtration, humidity control, and
- 56 conditioned ventilation, particularly for those suffering from Chronic Diseases such as Asthma,
- 57 COPD, Diabetes, Cardio-vascular Diseases, Allergies, and Neurological Diseases including
- 58 headaches throughout Fulton County.
- 59 BE IT FURTHER RESOLVED, that the Fulton County Board of Commissioners hereby
- 60 encourages landlords within Fulton County to provide the highest rated filter in the HVAC systems
- that the system can reasonably accommodate, eliminate sources of water intrusion, provide
- adequate humidity control, and provide improved filtered and conditioned fresh air ventilation
- 63 through the HVAC system.
- 64 BE IT FURTHER RESOLVED, that the Fulton County Board of Commissioners hereby urges
- and requests that municipalities located within Fulton County consider revising their building
- 66 codes to require HVAC systems that can utilize a MERV 13 filter, provide adequate humidity
- 67 control to maintain the humidity near or below fifty percent at room temperature, and fresh air
- 68 ventilation through the HVAC system.
- 69 **BE IT FURTHER RESOLVED**, that the Fulton County Board of Commissioners hereby urges
- and request that municipalities located within Fulton County consider utilizing code enforcement
- 71 to require landlords to accommodate Asthma, COPD and other disorders associated with the
- 72 indoor air quality as required under the American Disability Act.
- 73 BE IT FURTHER RESOLVED, that upon adoption the Clerk to the Commission is hereby
- directed to provide a copy of this Resolution to the Fulton County Board of Health and to each
- 75 municipality located within Fulton County Georgia, with the expectation that adoption of this
- 76 Resolution will increase community awareness and educate citizens on the significance of Indoor
- 77 Air Quality.
